

## ELMS iPad Contract and Financial Consent Form 2017-18

This consent form outlines the responsibilities, repair and replacement costs associated with the usage of an iPad from ELMS. The signature form must be completed and returned to school before a student will be issued an ELMS iPad .

### iPad Functions:

The iPad is a multifunction device that allows for the following:

- Connection to open or secured wireless networks
- Access the Internet (e.g. access online accounts, browse the Internet, etc.)
- Taking pictures
- Recording audio and video
- The use of chat features in relevant applications
- The use of pre-installed instructional apps

**Non-instructional use of the iPad functions is not endorsed.** Students have received instruction on appropriate uses of these functions (e.g., The iPad has the ability to take pictures, however, students are not allowed to take pictures without the subject's permission.)

**The HCPSS has installed and placed appropriate restrictions on content settings.** It is a violation of this contract to attempt to or to tamper with or remove profiles (files that apply settings and restrictions to the device), "jailbreak" the device, or reset the device to factory settings.

**Content Filtering: The HCPSS iPads are configured with the best practices for teaching and learning, technology security, and functionality in mind.** A content filter application blocks categories of websites that are considered inappropriate for student viewing. The filter works through categorization of sites, but due to the complexity of the Internet, and to err on the side of caution, sites may occasionally be categorized incorrectly
